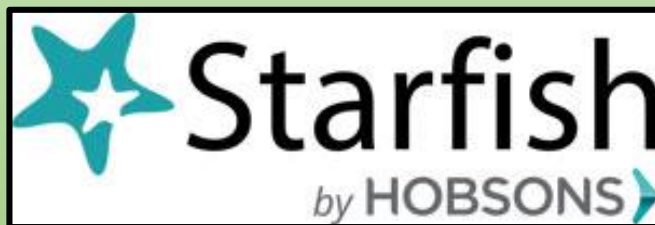

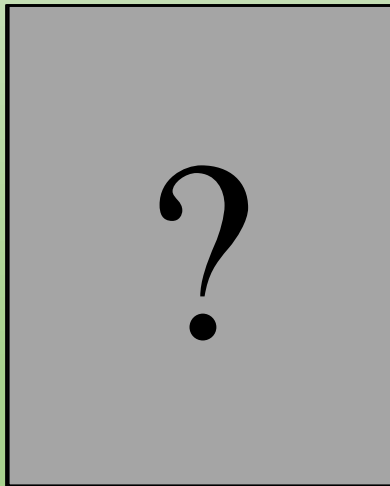

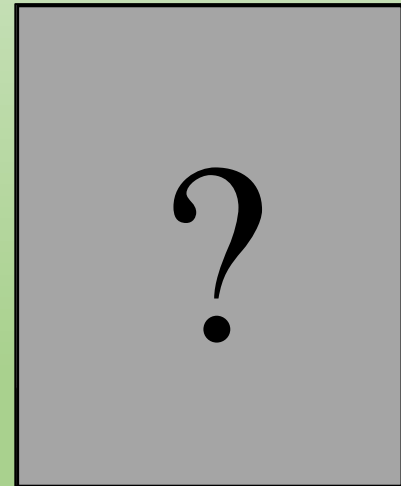

MAIR Membership Typology

Section 1. Membership.

Membership is individual and open to anyone with an interest in higher education and institutional research. - Regular MAIR conference attendees & MAIR members



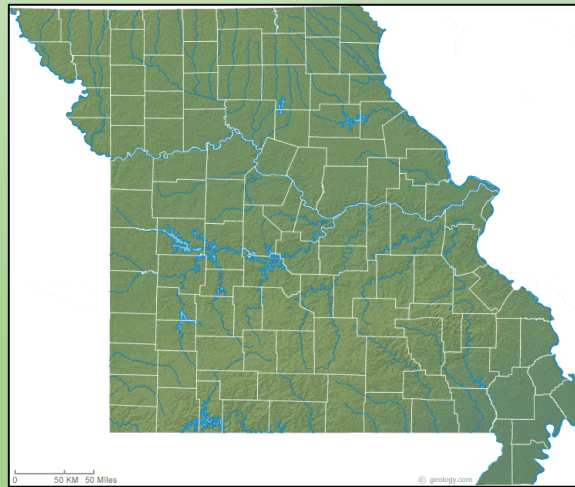
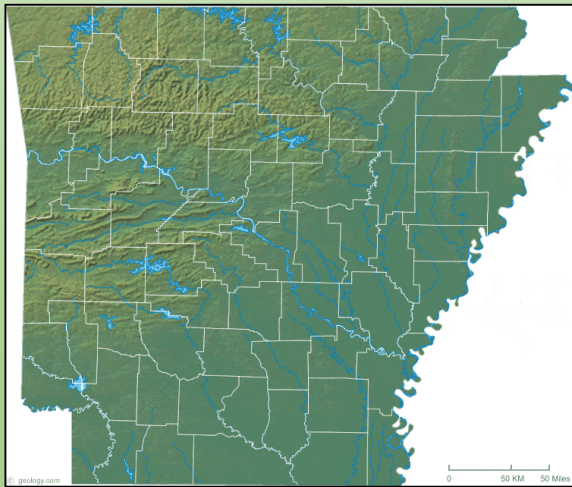
MAIR Membership Typology

MAIR Membership Typology

 - Currently register just like Regular Conference Attendees/Members
 - Not defined in Constitution & Bylaws



MAIR Membership Typology

- Invited Speaker
 - Are not registering.
 - Not defined in Constitution & Bylaws
